# 'TEST & GO' TRAVEL PROGRAMME

(Starting 1 November 2021)

### 'TEST & GO' TRAVEL REQUIREMENTS (exempt from quarantine) Applicable to fully vaccinated foreign visitors from approved low risk countries as listed <u>here</u>

- The person/s travelling must have been in an approved country (or a mix of approved countries) for 21 days or more prior to arrival in Thailand, have arrived by air, and present/adhere to the following:
- They must register documentation in advance on the new <u>Thailand Pass</u> portal. They must also be in receipt of a Thailand Pass QR Code to display to the airline, and to screening officers at the immigration checkpoint. Note that the Thailand Pass system will replace the <u>Certificate of Entry</u> from 1 November 2021.
- A COVID-19 vaccination certificate for all travellers 12 years old and above dated within 14 days to one year prior to arrival, with a vaccine registered with <u>Thai Ministry of Public Health</u> or approved by <u>WHO</u>.
- COVID-19 insurance coverage of minimum US\$ 50,000.
- A negative RT-PCR test within 72 hours of boarding a flight to Thailand is applicable to all arrivals.
- A payment confirmation for no less than a 1-night stay upon arrival at a hotel certified through the <u>Amazing Thailand Safety & Health Administration Plus (SHA+)</u> programme.
  - Payment confirmation must also include the purchase of approved transportation from the airport, the required RT-PCR COVID-19 test on arrival and an Antigen Test Kit (ATK) per person.
  - The selected SHA+ hotel must be within a 2-hour drive of the entry airport.
- All Travellers must undergo a screening upon arrival which includes immigration procedures, a RT-PCR Covid 19 test (children under 6 will undergo a saliva test) and installation of tracking application MorChana which must be always kept 'on'.
  - ✓ Travellers must wait for their results within the accommodation only. Test results should be available within 24hrs.
  - ✓ If testing <u>negative</u>, travellers can continue with their holiday and travel to other destinations in Thailand. Restrictions to some areas may still apply.
  - $\checkmark$  If they test <u>positive</u>, travellers will be taken to a hospital and must isolate.
- Travellers must self test with pre-purchased ATK on day 6-7. Results are to be shown to hotel staff, as well as recorded on the MorChana App.

BLUE ZONE SANDBOX TRAVEL PROGRAMME

## PRE-ARRIVAL REQUIREMENTS

- Travellers can choose from 17 'Blue Zone' destinations\* for their first 7-night mandatory stay within the destination before being able to move on to other parts of Thailand (some restrictions may apply).
- COVID-19 vaccination certificate dated within 14 days to 1 year prior to arrival with a vaccine registered with <u>Thai Ministry of Public Health</u> or approved by <u>WHO</u> (applicable to those 18 years old and over)
- Must have registered documentation in advance on the new <u>Thailand Pass</u> portal and be in receipt of a Thailand Pass QR Code to display to the airline, and to screening officers at the immigration checkpoint.

Note: The Thailand Pass system will replace the Certificate of Entry from 1 November.

- Hotel booking and proof of prepayment for 7 nights with hotels certified by <u>Amazing Thailand</u> <u>Safety & Health Administration Plus (SHA+)</u> initiative.
  - If less than 7 nights, visitors must have a confirmed air ticket out of Thailand and payment confirmation for intended duration.
- Proof of prepayment for RT-PCR test and Antigen Test Kit (ATK) arranged through the booked SHA+ hotel.
- COVID-19 insurance coverage of minimum US\$ 50,000.
- Negative RT-PCR test within 72 hours of boarding flight to Blue Zone destination (applicable to <u>all</u> ages).

## ARRIVAL AT BLUE ZONE DESTINATION

- Travellers must undergo Immigration and Customs procedures and COVID-19 screening at their own expense.
  - Those aged 6 years and above are required to take a RT-PCR Test upon arrival at chosen point of entry.
  - Children under 6 years will have a saliva test.
- Travellers must download and install the alert/tracking application <u>MorChana</u> and set the application to 'on' at all times for the full duration of their visit to Thailand.
- Flight transits through Bangkok are only permitted to Samui at present via approved sealed flights with Bangkok Air. Reservations for these internal flights must be made in conjunction with the booked international flights.
- Transfers should be made through SHA+ approved providers. Destination Asia Thailand is SHA+ approved. Hotel must be within 5-hour drive of entry airport.

#### \*BLUE ZONE destinations include:

Bangkok, Krabi (the whole province including Phi Phi), Phuket, Phang-Nga (the whole province including Khao Lak and Ko Yao), Trat (Ko Chang), Ko Samui + Ko Pha-ngan + Ko Tao, Chiang Mai, Petchaburi (Cha Am), Prachuap Khiri Khan (Hua Hin and Nong Khae), Pattaya and Jomtien, Rayong (Ko Samet), Ranong (Ko Phayam), Samut Prakan, Loei, Buriram, Nong Khai, Udon Thani.

# BLUE ZONE SANDBOX TRAVEL PROGRAMME

Applicable to fully vaccinated foreign visitors from high risk countries NOT listed here.

## STAY IN THE BLUE ZONE

- Upon arrival at the hotel, travellers must stay in their room until they are notified of their RT-PCR test results (within 24hrs).
- Once notification is received, travellers can move around the Blue Zone destination as they wish.
- On days 6 or 7, travellers must self-test with pre-purchased ATK. Results must be shown to hotel staff, as well as recorded on the MorChana App.
  - $\checkmark$  If they test <u>negative</u>, they can continue with their holiday in the destination.
  - ✓ *If they test <u>positive</u>, they will be taken to a hospital and must isolate.*
- Travellers planning to travel outside their chosen Blue Zone destination must obtain a 'Transfer/Release Form' issued by their original hotel indicating they have completed the required 7-night stay and showing negative results of their two COVID-19 tests.

Travellers who arrive by air or sea and have not been vaccinated, are without a vaccine certificate, or only partially vaccinated will be required to enter a 10-day quarantine and undergo two RT-PCR tests – first upon arrival on day 0-1, and the second on day 8-9 as part of the Alternative Quarantine (AQ) programme.

## ► DEPARTURE FROM THE BLUE ZONE

- After completing a 7-night stay and testing negative in their Antigen Test (conducted on day 6 or 7), travellers will receive a 'Transfer/Release Form' from the hotel and will be able to travel to other destinations in Thailand. Restrictions to some areas may still apply.
- If staying less than 7 nights, travellers are not allowed to travel outside the chosen Blue Zone.
- When travelling to other countries, travellers are advised to follow the guidelines and measures applicable to those respective countries.
